It is pleased to inform that the District Collector, Karaikal has been authorized to issue sanction in respect of the Group 'C' and 'D' employees of the various Government Departments in Karaikal District for G.P.F. advance under Rule 12(2) of GPF (CS) Rules, 1960 and Part-final withdrawals under Rule 15 of GPF (CS) Rules, 1960 vide G.O. referred above. It is therefore informed to send proposals for issue of sanction for temporary advances and part-final withdrawals from G.P.F. Accounts in respect of Group 'C' and 'D' employees to this office from January 2009 onwards. The proposal should be in full shape of the following in note file:

- a) A covering letter in Note form
 - b) Duly filled-in application
 - c) GPF Account Slip in original
 - d) Copy of sanction for temporary advance or part-final withdrawal last drawn
 - e) Draft sanction order
- Application for either temporary advance or part-final withdrawal should be made once in three months only;
 - Proposal should reach the Collectorate on or before 20th of every month (proposal received after 20th will not be entertained in any case);
 - Certificate regarding subscription/refund of advance/withdrawal should be recorded by the DDO in the individual application.
 - Each proposal should not exceed 10 Nos. of sanctions.

All the Heads of Offices and Drawing and Disbursing Officers are hereby informed to strictly adhere to the above conditions for the smooth functioning of the office.

In the G.O second read above, the Lieutenant-Governor was pleased to delegate the following powers under Rule 18 of Delegation of Financial Power Rules, 1978 for according administrative approval and expenditure Sanction for Schemes/Works under Non-Plan and Plan as detailed below:-

2. The proposal for delegating enhanced powers to the Collector, Karaikal, based on the recommendations made by the Committee constituted for examining the administrative set up of Karaikal District and powers to be vested on the Collector, Karaikal is engaging the attention of the Government. After careful consideration of the recommendations, the Government have decided to delegate enhanced financial powers. Accordingly, the Lieutenant-Governor, Puducherry is pleased to re-delegate the powers under Rule 18 of the Delegation of Financial Power Rules, 1978 for according administrative approval and expenditure sanction for Schemes/Works under Non-Plan and Plan as detailed below in modification of the G.O second cited.
