Tender schedule can be downloaded from the [www.etenders-pwdpondy.in](http://www.etenders-pwdpondy.in) only and the tender schedules cannot be purchased from the Office of the Executive Engineer by remitting the cost of tender schedule in the Office of Executive Engineer and no pre-request for issue of tender schedules will be entertained in the Office of the Executive Engineer.

The contractors who had downloaded the Tender Schedule from the website shall submit the Tender Schedule to the **Executive Engineer, Irrigation and Public Health Division**, Public Works Department, Karaikal before the schedule time of closing. **The contractors who downloaded the NIT from the website shall submit the Tender Schedule in two envelopes sealed in a single cover. The first envelope shall be**

**placed with copy of registration letter, required amount of cost of Tender Schedule, EMD in the prescribed format both drawn on or before the scheduled date of tender availability in the Website (contractors produce proof of Dealership license, EMD and cost of tender schedule as mentioned above) and the envelope shall be superscribed as 'EMD'/ Cost of schedule" and the other envelope shall be superscribed as TENDER SCHEDULE' wherein the duly filled NIT shall be placed and sealed.**

The Earnest Money should be deposited by cash at Division office/ receipt of Treasury Challan/Deposit at call receipt of a Scheduled Bank/Fixed Deposit receipt of a Scheduled Bank/Demand Draft of a Scheduled Bank and submitted along with the Tender. The Earnest Money should be drawn in favour of The Executive Engineer, Irrigation & Public Health Division, Public Works Department, Karaikal. **Fixed Deposit Receipts will be accepted as EMD only if period of Deposit is equal to or more then Six (6) Months**

All the tenderers shall follow the procedure prescribed below.

1. All the contractor shall submit the Tender schedule in **Two** sealed envelopes placed in a single cover. The first envelope shall be placed with EMD/ receipt from division in the prescribed format drawn on before the schedule date of availability of tender in the website with proof of document with their eligibility as per the conditions of Tender notice and the envelope shall be super scribed as EMD and the other envelope shall be super scribed as "TENDER SCHEDULE".

2. On the scheduled date of opening, the tender schedule of all the contractors, the cover super scribing EMD shall be opened first and on fulfillment of payment of EMD, eligibilities only other the envelope super scribing as TENDER SCHEDULE will be opened. The contractor's envelope "Tender schedule" which does not satisfy the conditions of Tender notice will be returned unopened.

If the opening day of tender happens to be a Public Holiday, the Tender will be received and opened on the next working day. The time allowed for carrying out the works as mentioned in the Column No. 7 includes monsoon period reckoned from the 10<sup>th</sup> day after the date of written order to commence the work

The Earnest Money should be deposited by receipt of Treasury Challan / Deposit and call receipt of a schedule Bank / fixed Deposit receipts of a Scheduled bank / Demand Draft of scheduled bank.
