1. Tender will be received by the Commissioner, Neravy Commune Panchayat as per the date and time mentioned above.

2. Tenders forms and conditions of contract can be had from the Neravy Commune Panchayat on payment of Rs.500/- plus (+) VAT @ 4% by Cash for each work, as cost of Tender Schedule (non refundable) and on depositing E.M.D. as noted in the column No.4 above, in the form noted below.

3. The Earnest Money should be deposited by receipt of Treasury Challan/Deposit at call receipt of a Scheduled Bank/Fixed Deposit receipt of a Scheduled Bank/Demand Draft of a Scheduled Bank and submitting along with the application requesting the tender schedule. The Earnest Money should be drawn in favour of The Commissioner, Neravy Commune Panchayat, Neravy.
4. If the opening day of tender happens to be a Public Holiday, the same will be opened on the next working day.
5. The time allowed for carrying out the work will be including the monsoon period from the tenth day after the date of written order to commence the work.
6. The tender of the contractors who do not deposit earnest money deposit in the prescribed manner will be summarily rejected.
7. The Neravy Commune Panchayat Council reserves the right to reject any tender without assigning any reasons therefore.

The Contractors who had downloaded the NIT from the website shall submit the tender schedules in 3 envelopes sealed in a single cover. The first envelop shall be placed with required amount of cost of tender schedules and the second envelop shall be placed with required amount of EMD in the prescribed format drawn on or before the scheduled date of receipt of application and proof of documents on their eligibility as per the conditions of Press Notice and the list of works on hand and envelop shall be superscribed as EMD, COST OF SCHEDULE and the other envelop shall be superscribed as TENDER SCHEDULE, wherein the duly filled NIT shall be placed and sealed.
